As we prepare for Pesach, we look forward to gathering with friends and family around our Seder tables. The night of Pesach is a powerful moment, a time when less connected Jews rekindle their connection. It is also a moment when generations come together.

At the Seder table, parents connect with children, and children with grandparents. This bond between generations is a foundational part of our Jewish lives. In the weeks between Pesach and Shavuot, it is customary to study "Pirkei Avot" (Chapters of the Fathers). # Financial Update from Our Treasurer

### Overview

I am pleased to share with you the financial report of Congregation B'nai Israel as of

February 29, 2024. Despite the challenges of the pandemic and the aging of our building, we have managed to maintain a stable and healthy financial position, thanks to the generosity and commitment of our members and donors.

#### Revenue

Our total gross revenue for the first eight months of the fiscal year 2023-2024 ("FY 23-24") was \$530K, which is an increase of \$205K (63.1%) compared to the same period last fiscal year. This growth was mainly driven by the following factors:

- Donations were up by \$46K (83.1%), reflecting the strong support of our community for our programs and services.
- High holiday revenue was up by \$20K (21.7%) despite lower pricing for premium seats, thanks to the call to our members to increase their Kol Nidre donations.
- Other revenue, which includes grant reimbursements and special fundraising, was up by \$57K (basically \$0 last year).
- The remainder of the increase is due to a reporting change for the three-year commitments to our "Fund the Future" campaign.



Membership revenue year over year is flat. While some families terminated their

membership, the rates paid by new families helped bridge the difference. Our current membership includes 161 families, with applications in process for two new families.

We are so very gracious to <u>all</u> our members who continue to support the Shul through their dues, donations, participation, and response to our financial needs as they arise.

### **Expenses**

Our total expenses for the first eight months of FY23-24 were \$463K, which is an increase of \$69K (17.6%) compared to the same period last fiscal year. This increase was mainly due to the following factors:

House expenses were up by \$82.4
 (61.3%), reflecting the higher costs of maintaining and repairing our building and infrastructure, as well as the increased spending on snow removal and utilities.



- Other expenses, which include office and ritual expenses, were down \$14.9K (5.8%).
- Note that our expenses include amounts spent to date on grant-related expenses and our revenues include reimbursements received to date.

### **Balance Sheet and Budget Performance**

As of February 29, 2024, our balance sheet showed operating cash of \$190K, which excludes reimbursable outlays for grant-related work. This represents a healthy cash reserve that allows us to meet our obligations, fund upcoming programming, address ongoing building repairs and improvements, and invest in our future. We have an additional \$105K in our cemetery account.

Relative to 8/12ths of the FY23-24 budget, we are ahead on gross revenue by \$87.2K (+19.7%) and behind on overall expenses by \$20K (-4.5%). If things remain on track, we should beat our budget and show a small profit for the year.

On behalf of the entire board, I thank you for your continued support of Congregation B'nai Israel and our collective vision for the future.

# Meet Etan Bluman - Our High Holiday Chazan

Etan Bluman has led Rosh HaShana and Yom Kippur Davening for the past eleven years, including five years at the Young Israel of West Hartford, CT. Prior to West Hartford, Etan led High Holiday services at synagogues in Passaic and East Brunswick, NJ. More recently, over the past two years, he led the Mechitza Minyan here at B'nai Israel.

Etan aims to create an inspirational and meaningful Davening experience for the congregation with a strong focus on the "Nusach HaTefillah." "Nusach HaTefillah" refers to the classic, traditional tunes that have been sung in Shuls over the generations.

Etan has a unique window into the importance of tradition. He was trained for his Bar Mitzvah and as a Chazan by his grandfather, Cantor Jerome Kopmar, a renowned Chazan and composer. Cantor Kopmar—a major proponent of tradition in Tefilla—founded the Beth Abraham Youth Chorale, which toured internationally throughout the 1970s.

Etan's love of Tefilla and melodies has been nurtured and shaped by his grandfather, as well as by Rabbi Yosef



### What do you love most about the Shul?


The Shul has always kept its family oriented environment over the years and members are friends with each other on a social level.


